SUPPORTING FINANCIAL DOCUMENTS

Expiration date must be within 6 months of the start of classes, but no later than class start date.** Please carefully review the following acceptable examples of financial documents:

- Personal funds – A recent bank letter or bank statement.
- Funds from family or sponsor – Bank statement along with an affidavit of support containing both the student's and sponsor's name, relationship, and amount of funds available for the purpose of the applicant's studies. You may use the bottom of this form for your affidavit of support. Funds must be shown at the current USD conversion rate.
- As an option, you may instead submit a bank letter on official letterhead containing the name of the sponsor, relationship to the applicant, name of the applicant, and the USD amount available for the purpose of the applicant's studies.
- Government or other sponsoring agency – A signed copy of the scholarship or award letter stating the amount, name of the recipient, and duration of the award.
- Examples of financial documents that will not be accepted include:
 - Annual salary statement
 - Real estate
 - Investments, stocks, or other accounts from which money cannot be withdrawn
 - Family Business account
