SUPPORTING FINANCIAL DOCUMENTS

- Personal funds: A recent bank letter or bank statement.
- Funds from family or sponsor: Bank statement along with an affidavit of support containing both the student's and sponsor's name, relationship and amount of funds available for the purpose of the applicant's studies. You may use the bottom of this form for your affidavit of support. Funds must be shown at the current USD conversion rate.
- As an option, you may instead submit a bank letter on official letterhead containing the name of sponsor, relationship to the applicant, name of the applicant and the U.S. dollar amount available for the purpose of the applicant's studies.
- Government or other sponsoring agency: A signed copy of the scholarship or award letter stating the amount, name of the recipient and duration of the award.

- Annual salary statement
- Real estate
- Investments, stocks or other accounts which money cannot be withdrawn
